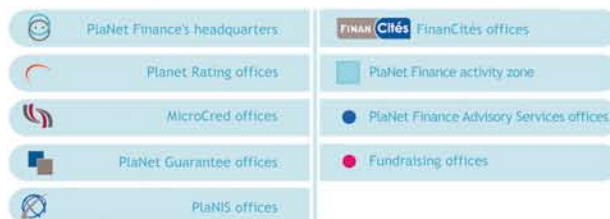
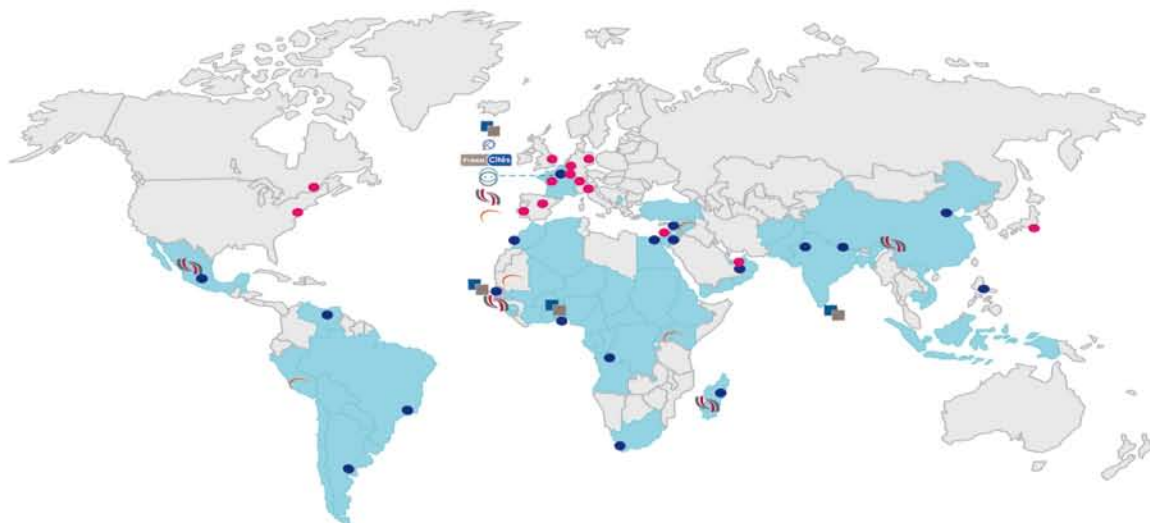


A commitment: a set of activities to develop the access to financial services
